A meeting of the Conway Planning Board was held on Thursday, May 27, 2021 beginning at 7:00 pm at the Conway Town Office in Conway, NH. REVIEW AND ACCEPTANCE OF MINUTES

The minutes of May 13, 2021 should be amended as follows: page 5, paragraph 4, line 3 should read "...porch. Mr. Corbett Chandler asked...; and page 5, paragraph 7, Alternate Member, line 4 should read "...and Mr. Corbett Chandler abstaining...".
